And whereas, Rainelle Medical Center is a proud Partner in Education with Western Greenbrier Middle School,



And whereas, the School-Based Health Program staff provides medical and mental health services to students at the above mentioned schools,




And whereas, the Schools provide space to the School-Based Health Program free of charge and allows access to students who need medical and/or mental health care,




